

Purpose Of Fall/Spring Meetings

Two half-day MCTA membership meetings conducted by the MCTA officers annually during the school year to focus on MCTA's annual career and technical education (CTE) priorities, needs, and issues, as well as professional development presentations on best and promising practices in education.

These meetings further the exempt purpose by providing a venue for membership to solve practical educational problems among their MCTA colleagues which can be translated into more effective CTE program delivery in their local school systems. These meetings are held virtually using Google Meet or are hosted by a local school district. (2 half-days annually (Fall / Spring))



Survey

The responses that we gather will help us (the executive team) develop a framework for an MCTA service model for leveraging technology to support administrators and teachers. We could then use the service model to help us recruit teachers to join ACTE-Maryland. Survey sent to membership on March 23rd via ACTE-Maryland website.

- 1. What are your needs, i.e. what help could you use from other Maryland LEAs?** *Sample response from BCPS: Our HVAC and Diesel Truck and Power Systems are singleton programs in BCPS, and they could benefit from virtual professional learning communities with job-alike teachers.*
- 2. What can you offer, i.e. what support could you provide to other Maryland LEAs?** *Sample response from BCPS: For three consecutive years, we facilitated teacher cohorts based on the Program Improvement Process for Equity (PIPE) from the National Alliance for Partnerships in Equity (NAPE). We could support other LEAs in developing the program.*



Awards Process

MCTA operates as an approved state chapter for the Association of Career and Technical Education (ACTE). Each year ACTE sponsors a national awards program for affiliated State organizations or chapters.

Deserving candidates for these awards have demonstrated their commitment to CTE through their innovation, accomplishments and contributions to the CTE community. Award recipients will then be judged, and Maryland ACTE award winners will have their nominations forwarded on to be considered for the ACTE Region I Awards.
